# **FTCG Constitution**

The FTCG Constitution has been revised and brought up to date, many thanks to FH for this revision.

The meeting unanimously agreed to adopt this revised 2023 version.

# Gates along Thurstonland Road to the recreation ground

One gate was fitted, then damaged. Kirklees repaired the gate within a week and thanks have been extended from the FTCG via Cllr Armer. Cllr Armer has requested details from Kirklees as to when the second gate will be fitted.

# **PROW Signposts**

All the PROW signs highlighted in the report compiled by KH have now been replaced or repaired. Thanks have been extended to the relevant department in Kirklees via ClIr Armer.

# **Speeding**

Cllr Armer is still liaising with Kirklees on behalf of the FTCG to try and address the continuing problem of traffic speeding on the roads leading into the village. Suggested options of traffic calming and moving the 30mph speed limit sign on Thurstonland Road further away from the village have unfortunately been refused so far.

A SID (Speed Indicator Device) is scheduled to be placed in the village in February. This could be slightly delayed due to concerns that it's not functioning correctly and might need a repair.

Cllr Barraclough has suggested other options and provided a useful link which NC will look into and report back to the FTCG.

Many thanks to Clirs Armer and Barraclough for all their support with these ongoing concerns.

#### Yew Tree Farm

There have been minor changes to the three planning applications to Yew Tree Farm (2021/93006, 2021/93007, 2021/92969).

Summary of changes are;

GREEN BELT- reduced incursion from around 10m to 8.5m

RETENTION OF TPO TREE- changing entrance to development 1.2-1.5m to East

PLOTS 13,14,15- moved further away from Church

NO CHANGE TO REMOVAL OF T4 (TPO)-Tree still to be removed (Plot 10) SE corner

PLOTS 10-13. Reduction in glazing overall

NO CHANGE TO SIZE, SCALE, HEIGHT OF ALL NEW BUILDS

SEPARATION OF PLOTS 17&18- Car park removed

PLOT 9- reduced glazing to front not rear.

NO CHANGE TO MAIN PARKING- To be softened by "more dense" planting.

The last revisions 19/1/2023 and comments to be submitted by 7/2/2023

Yew Tree Farm is therefore not on the HW planning committee agenda for 9<sup>th</sup> February. The next planning committee date is 16<sup>th</sup> March 2023.
